Let's Talk Human Trafficking

- Intending to subject or knowing that a person will be subjected to forced labor or commercial sex acts
- Victims of trafficking are not liable for criminal trafficking activity
- ▶ The buying and selling of people as if they were store-bought goods
- ▶ Human smuggling is not the same as human trafficking

Know the Signs for Human Trafficking:

Human Trafficking is a form of modern day slavery where people profit from the exploitation of others. Victims of Human Trafficking can be men, women, or children of all races, nationalities, and socioeconomic backgrounds. Human Trafficking takes place in cities and towns throughout Mississippi and is one of the fastest growing crimes in our state.

People may be vulnerable to trafficking if they:

- Have an unstable living situation
- Have previously experienced other forms of violence such as sexual abuse or
- domestic violence
- Have run away or are involved in the juvenile justice or child welfare system
- Are undocumented immigrants
- Are facing poverty or economic need
- Have a caregiver or family member who has a substance use issue
- Are addicted to drugs or alcohol

Signs to look for:

- Have a controlling parent, guardian, romantic partner, or "sponsor" who will not
- allow them to meet or speak with anyone alone or who monitors their movements, spending, or communications
- Are there bruises or other signs of physical abuse?
- Are there signs of psychological abuse?
- Is the person submissive or fearful?
- Is the person being controlled?
- Is the person being deprived of food, water, sleep, medical care, or other life
- necessities?
- Is the person allowed to be in public alone?
- Can the person freely contact friends or family?
- Is the person allowed to socialize or participate in extra-curricular or religious
- activities?

What is Sex Trafficking?

A person is made to perform a sex act

The use of force, fraud, or coercion

A minor under the age of 18 Sex Act=sex act exchanged for "anything of value"

Signs to Look For-Force

Providing a controlled substance to a person for purpose of compelling them against their will

Physical harm or beatings to control the victim

Physically restraining or confining someone

Use of a scheme or plan to cause any person to believe they or another person would suffer harm

Signs to Look For-Fraud

False promises regarding employment, wages, working conditions, love, marriage

Blackmail through photos/obtained information

Cause or threat of financial harm

Changes in work conditions, compensation, or the nature of the relationship

Signs to Look For-Coercion

Psychological manipulation

Document confiscation-Destroying documentation like a passport, drivers license, immigration documents

Shame and fear inducing threats

Using threats that could subject a person to criminal or immigration proceedings

Signs to Look For-In Your Field

Signs of physical abuse, black eyes, Bald patches, burns, scars, malnutrition, dehydration and dental problems	Victim has no spending money	Victim appears to be under the supervision of someone who is not a guardian	Victim seems anxious and/or depressed
Victim's story doesn't make sense	Focus of the relationship/interactions between an adult and a minor	The traveler who brought the victim in speaks for them or will not allow you to speak to them	Someone possessing a victim's travel documents, bags, money, and identification
Tattoos of names or branding	A traveler that is in constant proximity to a victim. They may even physically escort them to the restroom.	Victim may not have a cell phone or tablet in the concourse	Traveler or victim might make their ticket purchase in person at the last minute

Adults or minors in rural, suburban, or urban

All demographics, all ages

Runaway youth/homeless youth

The provider for the family

Who Are Possible Traffickers?

- Anyone can be a trafficker
- All races, genders, ethnicities
- School teacher, gym coach, medical professionals
- One of the biggest alarming factors, human trafficking is so prevalent
 - YOU have probably crossed paths with someone trafficking or being trafficked

Actions of Sex Traffickers

• Includes proactive targeting of those who are vulnerable, grooming behaviors are used as well • Includes isolation, confinement, monitoring • Includes movement and arranging travel Soliciting • Includes offering the person in exchange for something of value

Questions That Could Be Asked

- ▶ Where are you from?
- What brings you in tonight?
- How did you get here?
- What type of work do you do? Do you have a schedule?
- Are you paid for your work? What are your wages?
- Have you been threatened with violence while working or trying to leave?
- Are you being forced to do this?
- Do you have any identification?
- Do you have permission to eat, drink, or sleep?
- Where and with whom do you live? Do you have freedom to come and go?

Take Away

- Sex trafficking is real, and it is in our state
- Do not engage with the pimp/individual that brought a victim in
- Make sure to contact CPS and the Human Trafficking Statewide Coordinator if the victim is a <u>MINOR</u>
- Listen to the victim as if they are your dearest friend
- ▶ No victim of trafficking chose this life. It was chosen for them
- Encourage others to read up on the human trafficking signs to look for
- Human trafficking does not discriminate, remember it could be someone among you
- Make sure you voice your concern, don't stayed silenced
