



- PRIME SHOULD SUBMIT PHONE LOGS, EMAIL LOGS, AND FAX LOGS – WITH FOLLOW UP – DATES, TIMES, WHO DID THEY SPEAK WITH
- WHEN CONSIDERING GOOD FAITH EFFORTS IT IS NOT JUST LOWEST BIDDER – DBE EFFORTS AND BID PRICE SHOULD BE CONSIDERED INDIVIDALLY
