What Is the Disadvantaged Business Enterprise (DBE)?

The DBE program is a federal program operating under the guidance of the United States Department of Transportation. Authorization for the program comes from Federal Regulations, 49 CFR (Parts 23 and 26).

The goal of the DBE Program is to ensure that firms owned and controlled by minorities, women, and other socially and economically disadvantaged persons have the opportunity to grow and become self-sufficient so that they are able to compete on equal basis, with nondisadvantaged businesses for contracts and subcontracts in the transportation industry.



DBE BASIC REQUIREMENTS

Must be a member of a protected class or able to prove social and economic disadvantage and own 51% of business.

Personal Net Worth must be less than \$1.32million.

Must be a small business (as defined by SBA).

Must be in business for profit.



ROADMAP TO DBE CERTIFICATION IN MISSISSIPPI

Firms Located in Mississippi

- 1. Complete the UCP Application, listed as DBE Certification Application.
 - a. Page 13 needs to be signed and notarized.
- Supporting Document Checklist (Page 14)
 (all items might not apply to your business, we will judge this on a case by case basis)
 - a. PNW Statement
 - Page 1 needs to be dated at the top.
 - Page 3 needs to be signed, dated and notarized.
 - b. Federal Tax Returns
 - Please make sure that taxes for every year are signed and dated.
 - ii. If you filed electronically, make sure Form 8879 is included and signed.

After we have received all of the requested information, your application will be processed within 90 days.


